Notification No CO/P-R/02/2017 for recruitment of 24 (UR-14,OBC-06,SC-03,ST-01) number of Junior Engineer/Electrical in KRCL was published on 11/04/2017, accordingly written examination was conducted on 20/08/2017 and Document verification on 08/11/2017.

The following 23 candidates are empanelled for the post of Junior Engineer/Electrical, the break up is 14 UR, 6 OBC and 3 SC as eligible candidates from ST community could not be found . They will be called for medical test as per requirement. Candidates found not suitable in the required medical category will have no right for the post/job as advertised and no alternative post will be offered.
