PROVISIONAL CBT RESULT OF CANDIDATES FOR THE POST OF GOODS GUARD.

NOTIFICATION NO.CO/P-R/03/2018 DATED 05/04/2018

- 1) Konkan Railway Corporation Limited (KRCL) vide its Notification No.CO/P-R/03/2018 dated 05/04/2018 have issued Employment Notification for 4 categories of posts i.e. Station Master, Goods Guard, Senior Clerk & Accounts Assistant. The Computer Based Test (CBT) for this combined examination was conducted on 04/07/2018 & 05/07/2018. As per notified vacancies of 37 posts of Goods Guard, CBT result of 78 candidates for documents verification were declared on 22/02/2019. Due to absenteeism, candidates non turned up for joining, medically unfit candidates etc. it is necessary to call some more candidates qualified in the CBT as per their merit position for documents verification. The CBT Result is here by declared for calling additional 28 successful candidates for Document Verification. The result of successful candidates is only provisional. Roll numbers are arranged vertically in ascending order and not as per merit. List of provisionally qualified candidates are enclosed as **Annexure-I**.
- 2) In the above notified list, twice the number of candidates required to fill the unfilled vacancies are published.
- 3) DV will be tentatively scheduled in **Fourth Week of November-2019**. The exact date will be notified shortly. Candidates are advised to visit KRCL website www.konkanrailway.com regularly for getting themselves updated.
- 4) Online call letters will be issued 08 to 10 days prior to the scheduled date of DV. Candidates have to produce the print out of the same on the venue of DV.
- 5) No request for change of date of DV will be entertained. Candidates are advised to be prepared with all requisite documents as notified in notification and be prepared for more than one day stay, if required.
- 6) While due care has been taken in preparing the result, in case of any inadvertent error/s is noticed at any stage, KRCL reserves the right to rectify at later stage of selection procedure.
