I. Konkan Railway Corporation Limited (KRCL) vide it's letter dated 19/07/2019 has issued Provisional Panel for the posts of SSE/Electrical, SSE/S&T, SSE/Mechanical & SSE/Civil. Due to non turned up candidates, medically unfit candidates etc., it is decided to operate the replacement panel/additional panel for the post of SSE/Electrical & SSE/Mechanical. The replacement panel of successful candidates are only provisional.

1] Senior Section Engineer/Electrical:- 02 (UR-02) candidates are provisionally empanelled as per merit. They will be called for medical test as per requirement. Candidates found not suitable in the required medical category will have no right for the post/job as advertised and no alternative post will be offered. The panel will remain live for two years and if required can be extended. The provisional replacement panel for the post of Senior Section Engineer/Electrical is attached at **Annexure-I**.

2] Senior Section Engineer/Mechanical:- 01 (OBC-01) candidate is provisionally empanelled as per merit. He will be called for medical test as per requirement. Candidate found not suitable in the required medical category will have no right for the post/job as advertised and no alternative post will be offered. The panel will remain live for two years and if required can be extended. The provisional replacement panel for the post of Senior Section Engineer/Mechanical is attached at **Annexure-II**.

II. Medical examination will be tentatively scheduled in **2nd week of March-2020**. The exact date will be notified shortly. Candidates are advised to visit KRCL website www.konkanrailway.com regularly for getting themselves updated.

III. No request for change of date of medical examination will be entertained. Candidates are advised to be prepared for more than one day stay, if required.

IV. While due care has been taken in preparing the Provisional Replacement panel, in case of any inadvertent error/s is noticed at any stage, KRCL reserves the right to rectify at later stage of selection procedure.

V. Some candidates kept as standby will be called only if required, otherwise they have no claim for the job.
