PROVISIONAL PART PANEL-V FOR THE POST OF STATION MASTER NOTIFICATION NO.CO/P-R/03/2018 DATED 05/04/2018

I. Konkan Railway Corporation Limited (KRCL) has issued Employment Notification No.CO/P-R/ 03/2018 dated 05/04/2018 for filling up 55 vacancies of Station Master. The provisional part panels/ panels against replacements/shortfalls have been declared on 22/04/2019, 19/07/2019, 31/10/2019 and 05/12/2019. In continuation to the recruitment, now the following provisional Part Panel-V for the post of Station Master is notified against shortfall due to candidates not turned up for medical, joining, resigned during training period etc. The Part panel-V of successful candidates is only provisional.

In this Part Panel-V, 03(UR-03) candidates are provisionally empaneled. They will be called for medical test as per requirement. Candidates found not suitable in the required medical category will have no right for the post/job as advertised and no alternative post will be offered. The panel will remain live for two years and if required can be extended. Serial number mentioned in this provisional part panel-V is not as per merit order. After publishing the final panel, final merit order will be notified. The provisional Part Panel-V for the post of Station Master is attached at Annexure-I.

- II. Due to pandemic Covid-19 situation, the medical examination of empaneled candidates will be intimated later. The exact date will be notified shortly. Candidates are advised to visit KRCL website www.konkanrailway.com regularly for getting themselves updated.
- III. No request for change of date of medical will be entertained. Candidates are advised to be prepared for more than one day stay, if required. The candidate will have to join immediately after passing the medical examination, or as informed by the administration.
- IV. Some candidates kept as standby will be called only if required, otherwise they have no claim for the job.
- V. While due care has been taken in preparing the Provisional Part Panel-V, in case of any inadvertent error/s is noticed at any stage, KRCL reserves the right to rectify at later stage of selection procedure.
- VI. KRCL reserves the right to declare any candidate unsuccessful or delete his/her name from the notified provisional Part panel-V at any stage of the selection procedure, if any discrepancy or malpractice is noticed or brought to the notice of KRCL at any stage. The decision of KRCL in the matter shall be FINAL.
