I. COMPANY PROFILE

KRCL is a Schedule 'A' CPSE. KRCL operates passenger and freight trains and the innovate Roll-on-Roll-off service on the Konkan Railway line. KRCL has also been entrusted with two major construction projects, viz. Road over bridges in Jharkhand and Katra-Laole rail link in J&K.

Its Registered and Corporate offices is at Navi Mumbai.

The company employeed 5546 regular employees (Executives- 245 and Non-Executives- 5301) as on 31.03.2020.

The authorized and paid up capital of the Company was Rs. 4000 crores and Rs. 1283.06 crores respectively as on 31.03.2020.

The shareholding of the Government of India in the company is 52.20% as on 31.03.2020.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Operations & Commercial) is a member on the Board of Directors and reports to the Chairman and Managing Director. He/She is responsible for transportation of passengers and goods and the commercial and marketing activities of the Company related to such transportation.
