#### PROVISIONAL PART PANEL-III FOR THE POST OF VARIOUS TECHNICIAN CATEGORY ( TECHNICIAN-III/ELECTRICAL and ESTM-III ) NOTIFICATION NO.CO/P-R/02/2018 DATED 23/03/2018

I. Konkan Railway Corporation Limited (KRCL) has issued Employment Notification No.CO/P-R/02/2018 dated 23/03/2018 for filling up 65 vacancies (Technician-III/Electrical-38 and ESTM-III-27) of Technicians. The provisional part panels and some against replacements/shortfalls have been declared on 05/12/2018 and 05/03/2019. In continuation to the recruitment process and on being qualified in the required medical examination, now the following provisional Part Panel-III for the post of **Technician-III/Electrical and ESTM-III** is notified against shortfall due to candidates not turned up for medical, joining, resigned during training period etc. The Part panel-III of successful candidates is only provisional.

**Technician-III/Electrical:** In this Part Panel-III, **04(UR-02,OBC-01,SC-01)** candidates are provisionally empanelled. They will be called for further joining process shortly. The panel will remain live for two years and if required can be extended. Serial number mentioned in this provisional part panel-III is not as per merit order. After publishing the final panel, final merit order will be notified. The provisional Part Panel-III for the post of **Technician-III/Electrical** is attached at **Annexure-I**.

**ESTM-III:** In this Part Panel-III, **01(UR-01)** candidate is provisionally empanelled. He will be called for further joining process shortly. The panel will remain live for two years and if required can be extended. Serial number mentioned in this provisional part panel-III is not as per merit order. After publishing the final panel, final merit order will be notified. The provisional Part Panel-III for the post of **ESTM-III** is attached at **Annexure-II**.

II. Some candidates kept as standby will be called only if required, otherwise they have no claim for the job.

III. While due care has been taken in preparing the Provisional Part Panel-III, in case of any inadvertent error/s is noticed at any stage, KRCL reserves the right to rectify at later stage of selection procedure.

IV. KRCL reserves the right to declare any candidate unsuccessful or delete his/her name from the notified provisional Part panel-III at any stage of the selection procedure, if any discrepancy or malpractice is noticed or brought to the notice of KRCL at any stage. The decision of KRCL in the matter shall be FINAL.
