## Selection Process & other conditions:

- 1.0 Eligibility and Educational Qualifications
- 1.1 Eligibility: Minimum 12 / 16 years' experience (for JAG / SG respectively) in structural design of Bridges / Viaducts / flyovers for Railway / Road / Metro loading based on Indian (sound knowledge of IS, IRS, IRC and other relevant codes related to design) / International (EURO, BS & AASTHO) standards & basic design philosophy.

Preference shall be given to Candidate having experience in design of superstructure comprising of steel structures, composite structures, segmental bridges, U-girder, I-girder, balanced cantilever box girder with pre-stressed concrete technology & and should be proficient in use of various Structural Design softwares (like STAAD, MIDAS, LUSAS, SOFISTK etc.)

1.2 Educational Qualification:

ESSENTIAL: BE / B.Tech (Civil Engineering) from reputed institute / university with minimum 60% marks in aggregate

DESIRABLE: ME / M Tech (Structural Engineering / Geotechnical / Foundation Engineering / Earthquake Engineering) from reputed institute / university.

The qualification, age and recruitment procedure mentioned herein can be relaxed at the discretion of KRCL in deserving cases.

- **2.** Age: The candidates should not have crossed the upper age limit of 55 years as mentioned in table as on 01/07/2021
- **3.** Application Fees:

Applicants are required to deposit amount of Rs.500/- towards application fee in favour of FA&CAO/KRCL, SBI-Belapur, Account No. 5400000065, IFSC Code-SBIN0040524. Details of payment made (NEFT/UTR No etc) shall be attached / mentioned with application. The application fee is non-refundable.

Note: SC/ST candidates, minority candidates/Female candidates are exempted from payment of application fee, provided the SC/ST candidate encloses the caste certificate in Central Government format in proof thereof. In case of minority candidates affidavit in Rs.200 non-Judicial stamp paper is to be enclosed.

#### **4.** Mode of Selection

Only provisionally eligible candidates shall be called for selection. KRCL intends to call candidates about 10 times the number of vacancies notified for the post of Deputy Chief Engineer (Design) based on their Qualification and Experience. The selection will be by way of Personal Interview.

The specific date of selection will be intimated along with the list of short listed candidates through KRCL website. Candidates called for interview should carry original Application, Educational documents, Experience certificate & other documents mentioned in notification along with one set of self attested copies. Candidate with all clear records and as per merit to the extent of vacancy notified will be called for prescribed medical examination. The selected and medically fit candidate will be provisionally appointed based on the merit position.

#### Note:

Names of short listed candidates will be put up on our official website www.konkanrailway.com. Candidates are required to go regularly through KRCL website and appear for the Interview accordingly along with original copies of documents and testimonials.

- **5.** Perks and Allowance: KRCL follows CDA scale. Perks and allowance as applicable for the posts and payable to other regular employees shall be payable as per the extant rules of KRCL.
- **5.1** Pay scale: For deserving candidates, higher pay fixation may be given within same pay scale based on number of years of experience / additional professional degree or diploma of the relevant field maximum to the 4 increments. However, decision of KRCL in this regard will be final.
- **6.** Medical Examination.

The candidates will have to pass the prescribed medical examination as decided by the Management and to be conducted at the candidate's cost by Konkan Railway Corporation's Medical Authorities. The medically fit candidates will only be considered for employment in KRCL. No alternative job will be provided if selected candidate fails to qualify the prescribed medical test.

## 7. Posting:

The vacancy is for the Design Cell in Delhi. However, the selected candidate can be posted and transferred anywhere in the area of operation of Konkan Railway Corporation Ltd., including its project sites. The employees of Konkan Railway Corporation Ltd. are not eligible for transfer to other zones of Indian Railways / Production Units and Public sector Undertaking of Ministry of Railways.

- **8.** Probation: The selected candidate will be placed on Probation for a period of Two years and the confirmation will be subject to screening of APARs grading and clearance from the Director's Committee.
- **9.** Superannuation: The age of superannuation for KRCL staff is 60 years at present. The retirement benefits will be given as and if applicable on the date of superannuation.
