Total 91 candidates (68 Regular shortlisted candidates and 23 Standby candidates) following community-wise reservation rules, etc. have qualified for Document Verification.



- 5) Candidates are advised to bring all original documents and 1 set of self attested xerox copies (Land loser related documents(applicable to land loser candidates only),Date of Birth proof,Educational Qualification,Domicile Certificate,Valid employment exchange registration card,counter foil of e-call letter of CBT,Caste Certificate, etc.,(OBC candidates are required to bring latest Caste Certificate in the prescribed Central Government format indicating Non-Creamy Layer and OBC declaration) along with 3 sets of passport size colour photographs. All certificates should be either in English or in Hindi only. Where certificates are not in English/Hindi, self- attested translated version (In Hindi/English) should be produced wherever/whenever required. Certificates produced during the DV should be strictly in the prescribed formats. For more details, please see clause no.15 of notification no.02/2020 dated 28/10/2020.
- 6) Due to Covid-19 pandemic situation, candidates are advised to get Covid-19 negative(RT-PCR) test report along with them(which should not be more than 48-72 hours prior to the reporting date of document verification).If he/she have been already tested positive/quarantined for direct contact, kindly ensure that he/she should have completed at least 21 days from the date of testing/quarantine before reporting to the venue of DV. If not, the candidate should intimate to this office for further decision.
- 7) Candidates are requested to follow all safety norms related to Covid-19(maintaining social distance,wearing mask,sanitizing etc.) in the entire process of document verification(DV).
- 8) No request for change of date of Document Verification will be entertained. Candidates are advised to be prepared for more than one day stay, if required,as their medical examination will be conducted in the next day if possible. The candidates will bear the cost of medical test, as this is initial recruitment medical examination.
