I. COMPANY PROFILE

KRCL is a Schedule 'A' CPSE. KRCL operates passenger and freight trains and the innovate Roll-on-Roll-off service on the Konkan Railway line. KRCL has also been entrusted with two major construction projects, viz. Road over bridges in Jharkhand and Katra-Laole rail link in J&K.

Its Registered and Corporate offices is at Navi Mumbai.

The company employeed 5507 regular employees (Executives- 248 and Non-Executives- 5259) as on 31.03.2022.

The authorized and paid up capital of the Company was Rs. 8079.51 crores and Rs.5703.03 crores respectively as on 31.03.2022.

The shareholding of the Government of India in the company is 51% as on 31.03.2022.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Way & Works) is a member on the Board of Directors and reports to the Chairman & Managing Director. He is responsible for all construction activities, maintenance and upkeep of permanent way fixed structures as well as colonies and roads, and also maintenance and upkeep of track maintenance machines. He is also responsible for planning and design and other works relating to Bridges, Tunnels, Structures and Buildings. He also oversees work relating to drainage, water supply, procurement of track fittings, speed restrictions and security patrolling. The functional control, coordination and monitoring of Engineering signal and Telecom Electrical and

Stores departments vests with him.

III. ELIGIBILITY

The applicant should have technical/operational/project management experience/exposure for at least 5 years during the last 10 years at a senior level of management in Construction/Technical Consultancy Service preferably in Railway Sector, in an organization of repute.

Experience in Signaling and Telecommunications is desirable.
