Reference (i) above, a notification was issued for the post of Chief Mechanical Engineer/Project (CME/Project) on Deputation basis in KRCL at Belapur.

As per Railway Board's directives, vide reference iii above, selection process was completed, and the recommendation of Directors' committee and approval of CMD/KRCL was sent to Railway Board for issuing order of the short listed Executive Shri Manish Pradhan, CDE/MECH/ICF. In response, Railway Board informed that Shri Manish Pradhan can be spared only after the production of Vande Bharat stablizes. Thus, deputation of Shri Manish Pradhan, IRSME for the post of CME/Project/KRCL could not materialise.

Therefore, reference ii above, again a notification for the post of Chief Mechanical Engineer /Project (CME/Project) was issued. Against this notification i) Shri. Manish Pradhan, CDE/Mech/ICF ii) Shri Nitin Tenu Bhirud, Secretary to PCME-CR were found provisionally eligible for screening process. However, both the Executives who were called for screening process communicated their unwillingness.

It is pertinent to mention that, present CME/KRCL who is looking after the project related works along with Train operations has been selected as Director(Technical) in RITES. Hence, this post of CME/Project is required to be filled on urgent basis.

As there is an urgent requirement of Chief Mechanical Engineer/Project(CME/Project), a fresh notification has been notified on KRCL website at link www.konkanrailway.com --> Recruitment --> Current notifications.
