#### 1. <u>Eligibility Criteria</u>

- i) Handicapped Land losers whose land has been acquired for Konkan Railway line Project (Self / Sons / Spouse / Unmarried daughters / Grandsons/ Unmarried Granddaughters only) are eligible. \*Only one candidate per land acquisition (irrespective of family) is eligible. In case of ST candidates, there is no such limit of number per land acquisition.
- ii) Handicapped other than Konkan Railway land losers, who are Registered with Employment Exchanges with valid registration along Konkan Railway route within the jurisdiction of Konkan Railway Corporation Ltd. (Raigad, Sindhudurg and Ratnagiri Districts of Maharashtra; Goa State; and Karwar, Udupi and South Kannada Districts of Karnataka) are eligible. But priority will be given to landloser candidates only and after exhausting of landloser panel, second panel (other than landloser candidates) will be operated.
- iii) Definition of categories of the Handicapped: Definitions of the categories of disabilities for the purpose of reservation in the employment are as under:

#### a) Orthopedically Handicapped:-

- 1) Locomotor Disability means disability of the bones, joints or muscles leading to substantial restriction of the movement of the limbs or any form of cerebral palsy.
- 2) Cerebral Palsy means a group of non-progressive conditions of a person characterized by abnormal motor control posture resulting from brain insult or injuries occurring in the prenatal, peri-natal or infant period of development.
- 3) All the cases of orthopedically handicapped persons would be covered under the category of "Locomotor disability of cerebral palsy." (Please enclose the attested copies of Certificates).
- **b)** Hearing Handicapped:- Hearing impairment" means loss of sixty decibels or more in the better ear in the conversational range of frequencies. (Please enclose attested copy of the Certificate of audiogram of institute and registered medical authority in this regard).

#### c) Visually- Handicapped:-

- 1) Blindness refers to a condition where a person suffers from any of the following conditions viz;
- i) Total absence of sight; or
- ii) Visual acuity not exceeding 6/60 or 20/200 (Snellen) in the better eye with correcting lenses; or
- iii) Limitation of the field of vision subtending at an angle of 20 degrees or worse.
- 2) Low Vision: "Persons with low vision" means a person with impairment of visual functioning even after treatment or standard or standard refractive correction but who uses or is potentially capable of using vision for the planning or execution of a task with appropriate assistive device. (Please enclose the attested copies of Certificates)

Degree of Disability for reservation: Only such persons would be eligible for reservation in service/ posts who suffer from not less than 40% or relevant disability.

- 2. Physically Handicapped candidates are exempted from the payment of application and examination fees.
- 3. Educational Qualification:

Minimum: 10th pass (regular) or ITI or equivalent from recognized Board.

#### 4. <u>Age</u>

The candidates should be within the age group of 18 years (minimum) and 40 years (maximum) as on 01/01/2016 and further age relaxation of 5 years for SC/ST and 3 years for OBC candidates.

5. Job description: All those working designation which do not fall under safety category shall be open for Persons with Disability (PWDs) for different departments such as Personnel, Accounts, Commercial, Khalasi etc.

#### 6. <u>Mode of Selection</u>

Separate panel will be prepared for landloser candidates and other than landloser candidates. Priority for appointment will be given to landloser candidates and only after exhausting the panel of landlosers, the second panel (other than landlosers) will be operated depending upon the shortfall in the vacancies notified.

Based on the applications received, eligible candidates will be called for written examination. (The written test shall be based on 10<sup>th</sup> class standard consisting of 100 multiple objective type questions including general knowledge/awareness, mathematics and reasoning etc.) with time limit of 2 hrs. and 30 minutes. Those who qualify in the written examination will be called for scrutiny of documents as per merit order. #### 6. <u>Medical Examination</u>

The candidates will have to pass the prescribed medical examination to be conducted at the candidate's cost by Konkan Railway Corporation's Medical Authorities. The medically fit candidates will only be considered for recruitment in KRCL.
