**Sub: Physical Efficiency Test (PET): For the post of erstwhile Group-D.
Ref: Notification CO/P-R/01/2024 dated 16/08/2024**

- 1) Konkan Railway Corporation Limited (KRCL) vide its Notification No.CO/P-R/01/2024 dated 16/08/2024 have issued Employment Notification for filling up 190 vacancies in various categories, including 95 vacancies in erstwhile Gp-D post, i.e. Track maintainer (35 post) and Points man (60 posts). Result of Computer based Test (CBT) has been declared on 28/02/2025.
- 2) Total 73 candidates who have qualified in CBT for the post of Track maintainer and Points man were called for Document verification from 21/03/2025 to 22/03/2025.
- 3) Based on the result of CBT & Document verification, the list of provisionally eligible candidates to appear for Physical Efficiency Test (PET) is attached as **Annexure-A**.
- 4) The PET is scheduled to be held on 08/04/2025 at Community Hall, Konkan Railway Staff Colony, Behind Konkan Rail Academy (KRA), Opposite Madgaon Railway Station, Madgaon.
- 5) Roll numbers are arranged vertically in ascending order and not as per merit.
- 6) The list also contains the roll numbers of some of the candidates who have not yet submitted all the requisite documents. All those candidates whose document verification is not completed due to non-production of requisite documents on the date of DV, but called for PET, shall be required to produce the pending documents on or before the date given to them at the time of Document verification to decide their eligibility for PET. Documents submitted on or before given time, will be further verified to decide their candidature as per notification. They may be permitted for PET provisionally. In case of non-submission of pending documents within given time, their candidature will be treated as cancelled for the post of POINTSMAN/TRACKMAINTAINER and they will not be permitted for PET.
- 7) PET is qualifying in nature. Candidates failing in PET will not be considered for further recruitment process. Merit position will be based on performance in CBT and not PET.

The following criteria will be followed for the Physical Efficiency Test (PET):

MALE CANDIDATES	FEMALE CANDIDATES
Should be able to run for a distance of 1000 meters in 4 minutes and 15 seconds in one chance	Should be able to run for a distance of 400 meters in 3 minutes and 10 seconds in one chance

N.B.: Under no circumstances, second chance will be given for PET.

- 8) Call letters for PET will be sent to the candidates on their registered emails. Candidates have to produce the print out of the same on the venue of PET.
- 9) No request for change of venue and date of PET will be entertained. Candidates are advised to be prepared for more than one-day stay, if required at their own cost.
- 10) This is only the provisional list for PET and NOT the FINAL PANEL and it does not confer upon the candidates any right for appointment.
