- 1) Konkan Railway Corporation Limited (KRCL) vide its notification No.CO/P-R/01/2024 dated 16/08/2024 have issued Employment notification for filling up posts in various categories, i.e. Senior Section Engineer (Civil), Senior Section Engineer (Electrical), Station Master, Commercial Supervisor, Goods Train Manager, Technician-III (Mechanical), Technician-III (Electrical), ESTM-III (S&T), Assistant Loco Pilot, Points Man and Track Maintainer – IV. Computer Based Test has been conducted from 13/01/2025 to 16/01/2025 and result of the same has been declared on 28/02/2025.

Document verification for the post of Senior Section Engineer (Civil), Senior Section Engineer (Electrical), Commercial Supervisor, Points Man and Track Maintainer – IV has been conducted on 20/03/2025 to 22/03/2025 for regular as well as standby candidates. Medical examination of provisionally eligible candidates has been carried out for the post of Senior Section Engineer (Civil), Senior Section Engineer (Electrical) and Commercial Supervisor as mentioned in letter dated 17/03/2025.

- c) **Commercial Supervisor:** In this Part Panel-I against notified 05 (UR-4, OBC-NCL-1) vacancies, 02 (UR-1, OBC-NCL-1) candidates are provisionally empanelled. Panel will remain live for two years. Part panel of remaining 03 vacancies will be issued shortly. List of empanelled candidate is not as per merit. On finalization of entire selection process, final empanelment will be issued. The provisional part Panel-I for the post of **Commercial Supervisor** is attached as **Annexure-C**.
