The Provisional result of Computer Based Aptitude Test (CBAT) for the post of Station Master and Assistant Loco Pilot held on 17/04/2025 against notification no. CO/P-R/01/2024 dated 16/08/2024 has been published on 30/04/2025.

As mentioned in the notification, provisionally eligible candidates have been called for further selection process.

1) Document Verification (DV).

Provisionally eligible candidates are being called for DV as per their preference for the post for the respective PML and post in the order of merit, equal to the number of posts. Preferences given to candidates as mentioned in the notification. Further, an additional 30% of candidates as Standby candidates, over and above the number of vacancies, also being called for DV for the respective pay level and post. However, these standby candidates will be considered for empanelment only if there is a shortfall from the merit list or as a replacement against the shortfall because of non-joining recommended candidates in the working post or/and any other special requirements. Candidates as per their Roll numbers attached as Annexures.

The candidates will have to bear the cost of medical examination, as this is initial recruitment medical examination. Only fit candidate will be considered for empanelment against notified posts as per their preference and integrated merit (CBT+APTITUDE TEST) subject to availability of vacancies.

3) While due care has been taken in preparing the list, in case of any inadvertent error/s is noticed at any stage, KRCL reserves the right to rectify at later stage of selection procedure.
