Contents

1.0 Background :

Konkan Railway Corporation Limited **(KRCL)** is a Public Sector Undertaking under Ministry of Railways. Its main business areas are Train Operation between Roha in the State of Maharashtra and Thokur in the State of Karnataka, a vital link in India's railway network, plays a crucial role in connecting the western coastal region with the rest of the country. It operates in a geographically challenging terrain that requires consistent workforce engagement for track maintenance, station operations, security, and other critical railway functions. **KRCL is** also into the Construction and maintenance of Railway infrastructure & Projects in the areas of Rolling stock, Railway infrastructure and Technology. Given the increasing demand for efficient railway services, there is a need for reliable manpower to ensure smooth operations and infrastructure maintenance.

The work required involves hiring of personnel for various roles such as technical staff, maintenance workers, administrative support, security personnel, and customer service representatives. The selected manpower agency shall be capable of fulfilling these workforce requirements while adhering to safety and operational standards mandated by the Konkan Railway Corporation Limited (KRCL).

Applications are invited for registration from desirous contractors / agencies. The application, in the prescribed format, shall be submitted duly signed by the authorized signatories of the applicants. Applicants may please note that only factually correct information is to be furnished. In the event of detection of incorrect information, the Agency is liable to be summarily disqualified or terminated or black-listed. Format for certificate to be submitted, attached as **Appendix-VII.**

The qualification for registration of contractors and their eligibility limit for award of contract shall be determined on the basis of objective evaluation of their organization, past experience, technical qualifications and financial capabilities submitted by the firm.

If the application for registration is made by a proprietary firm, it shall be signed by the proprietor with his full typewritten name and full name of such firm with its current address.

If the application is made by a firm in partnership, it shall be signed by all the partners of the firm with their full typewritten names and current addresses, or alternatively by a partner holding power of attorney for the firm (a certified copy of the power of attorney shall accompany the application). A certified copy of the partnership deed and current address of all partners of the firm shall also accompany the application.

Registered Contractor shall not sub-contract any element of works to subcontractors without prior written consent of the CME, KRCL or his authorized representative.

The applicants shall furnish all details as per Annexures regarding their general and particular experience, financial position, personnel and equipment capabilities and other relevant information as demonstrated by the Applicant's responses in the forms attached to the Application for registration.

Failure to provide information essential for the evaluation of the applicant's qualification or failure to provide timely clarification or substantiation of the information supplied, may result in disqualification of the applicant.

2.0 Scope of work

The Scope of work for registered firms is as follows -

i. The successful agency will be expected to provide experienced and certified personnel for various technical roles within the railway sector, including but not limited to:

Providing manpower across various categories (skilled, semi-skilled, and unskilled) as per the specific needs of the organization.

- Engineering Graduates- Mechanical/ Electrical/ Electronics/ Civil Engineering.
- **Project Managers** (specializing in Maintenance/ infrastructure/ manufacturing)
- Welders (with experience in railway maintenance/ construction/ manufacturing/ fabrication)
- Technicians (with experience in railway maintenance/ construction/ manufacturing/ fabrication)
- Supervisors(with experience in railway maintenance/ construction/ manufacturing/ fabrication)
- Safety Officers
- All type of Industrial crane operator
- Vehicle drivers
- Painter
- Helper
- ii. Ensuring that the provided manpower possesses the necessary qualifications, certifications, and experience required for their respective roles.
- iii. Conducting pre-employment screening, including background verification, qualification checks, and medical examinations where required.
- iv. Ensuring compliance with labour laws, including minimum wage regulations, employment contracts, social security benefits, and workplace safety standards.
- v. Handling payroll management, including salary disbursement, tax deductions, and statutory benefits such as Employee Provident Fund (EPF), Employees' State Insurance (ESI), and other mandatory contributions.
- vi. Providing ongoing performance monitoring and evaluation of deployed manpower, including handling grievances, disputes, and disciplinary actions if necessary.
- vii. Managing timely deployment, substitution, and replacement of workforce as per organizational needs to ensure uninterrupted operations.
- viii. Conducting necessary training and orientation programs to enhance the efficiency and effectiveness of the hired personnel.
- ix. Ensuring adherence to ethical hiring practices, confidentiality, and non-disclosure agreements as applicable.
- x. Providing regular reports and updates on manpower status, payroll processing, compliance, and other relevant metrics as requested by the organization.

4.0 Evaluation Criteria

The evaluation will be done in three phases by the Technical Evaluation Committee (TEC) set up by KRCL. At any time during the process of evaluation, the KRCL may seek specific clarifications from any or all companies on the recommendation of the Evaluation Committee:

- I. Evaluation of Pre-Qualification Proposal.
- II. Evaluation of Technical eligibility.
- III. Evaluation of Financial eligibility.

The Technical Evaluation Committee (TEC) shall first evaluate the Pre-Qualification Proposal as per the Pre-Qualification Criteria mentioned below. The Pre-Qualification Proposal shall be evaluated based on the information provided by the company in the Pre-Qualification Proposal and the supporting documents. Companies' Proposals failing to either meet any of the Pre-qualification criteria or not furnishing the requisite supporting documents/documentary evidence will be rejected.

Stage I: Evaluation of Pre-Qualification Proposal.

Following are the essential qualifying criteria for the Agency to technically qualify for the assignment:

- The Agency should have EPF Code, ESI registration no., PAN, Central Goods and Services Tax Act, 2017 (CGST)/Integrated Goods and Services Tax Act, 2017 (IGST)/Union Territory Goods and Services Tax Act, 2017 (UTGST)/respective state's State Goods and Services Tax Act (SGST) also, as notified by Central/State Govt. & as amended from time to time and applicable taxes before bidding. Agency will ensure that full benefit of Input Tax (ITC) likely to be availed by them is duly considered while quoting rates.
- 2. Agency should be registered under the Contract Labour (Regulations and Abolition) Act 1970 laws and should submit copy of the same.
- 3. The Agency shall not have been black listed by any State Government, Central Government or any other Public Sector undertaking or a Corporation as on the date of RFE opening. An undertaking to this effect should be submitted by the Agency on its letter head. Format for certificate to be submitted, attached as Appendix-VII.

Note:

a. JV/ Consortium bidding shall not be allowed at any stage for fulfillment of eligibility criteria. b. Agency should sign all the pages of the documents submitted.

Stage II : Evaluation of Technical eligibility

The Technical Proposals of only those Firms will be evaluated, who qualify in the evaluation of the Pre-qualification Proposals. The Technical Proposals/presentations given by the shortlisted Firms will be analyzed by the Technical Evaluation Committee (TEC) constituted by the KRCL.

The qualification of the firms and the evaluation criteria for the Technical Proposal shall be as defined below in the Table. Each responsive proposal will be given a technical score.

Application of the firms shall be rejected at this stage if it does not respond to important aspects of this EOI or if it fails to achieve the minimum technical score i.e. 50 Marks.

Note: Experience of Housekeeping, watering of train etc will not be considered.

5.0 Terms and conditions for registered firms qualifying this EOI and registered with KRCL upon such qualification.

- i. Solvency Certificate to be submitted from a Nationalized or Scheduled Bank for an amount not less than Rs.50 lakh. Bid application form for the registration under this EOI will not be considered without Solvency Certificate.
- ii. The registration is without prejudice to the right of Konkan Railway Corporation Limited to terminate the registration within its validity period if:
 - a) Any information submitted by the firm for registration is found incorrect.
 - b) Adverse report on the performance of contractors given by nominated authority of KRCL.
 - c) Up gradation / down-gradation / deletion of contractor's name from the approved list will be done periodically based on their performance report.
- iii. The Contract executed with the Bidder(s) qualifying this EOI shall be governed by KRCL GCC Year 2022, in addition to all applicable Indian Laws and shall be subject to jurisdiction of the Law Courts in Navi Mumbai / Mumbai, only.
- iv. The agency shall comply with all statutory requirements, including labour laws, taxation, and social security regulations.
- v. The agency shall be responsible for the safety, conduct, and discipline of the deployed workforce.
- vi. Any misconduct or non-compliance by the workforce must be immediately addressed by the agency, with necessary actions taken as per regulatory and organizational requirements.

- vii. The agency shall maintain transparency in all dealings, ensuring proper documentation and timely reporting.
- viii. The contract will be performance-based, and non-compliance with agreed terms may result in penalties or termination.
- ix. The agency shall ensure that workforce deployment does not affect ongoing operations and shall provide a contingency plan for workforce replacements if needed.
- x. Payments will be processed based on successful service delivery and adherence to contractual obligations.
- xi. The agency shall agree to periodic audits and inspections by KRCL.
- xii. Any disputes arising under the contract shall be resolved through mutual discussions or as per the legal framework applicable under the KRCL GCC Year 2022.
- xiii. The persons deployed by the Successful firm shall not have any Police record/criminal cases against them. The Successful firm shall make adequate inquiries about the character and antecedents of the persons whom they are recommending. Any person deployed by the contracting Successful firm shall not indulge in acts of misconduct. In case any such incident comes to the knowledge or is brought to the knowledge of KRCL, the Successful firm will withdraw such person immediately and KRCL will be at liberty to take appropriate action against such person as well as the contracting Successful firm.
- xiv. The Successful firm shall conduct a thorough background verification of the candidate at its own cost. The background verification shall essentially include the verification of the following credentials:
 - Verification of education and academic credentials
 - Verification of prior employment
 - Criminal background checks for convictions including police verification
 - o Identity and address verification.
- xv. The Successful firm shall submit the report of background verification of the candidate within one month of his/her deployment at KRCL. In case the background verification report is delayed, an interim report needs to be submitted to KRCL within one month. Subsequently, the final background check report should be made available within 60 days (max) of the date of joining of candidate.
- xvi. The Successful firm shall ensure that the personnel deployed are medically fit. The Successful firm shall withdraw such employees who are not found medically suitable by KRCL immediately upon receipt of such a request from KRCL.
- xvii. The Successful firm shall be responsible for any damages done to the property of KRCL by the personnel so employed. KRCL shall recover the same from the Successful firm either from any monthly payments payable to the successful firm and/or from any other

payments due to the successful firm from KRCL including but not limited to any Security Deposit, Performance Guarantee, and/or any money due under any other Contract of KRCL and/or any Railway Administration of the Indian Railways with such successful firm.

xviii. KRCL shall not be responsible for any financial or other injury to any person deployed by Successful firm in the course of their performing the functions/duties under this Contract, or for payment towards any compensation, claims, damages, demands, costs, losses, awards, fines, charges, whatsoever, and the Successful Firm shall at all times fully indemnify KRCL and its officials from and against all such claims arising and/or likely to arise upon KRCL for any reason whatsoever, by any person whosoever, on account of award of this contract to the successful firm.

6.0 Appointment & Authority:

- i. Based on the response to the EOI, KRCL will short list the firms /Companies based on eligibility criteria mentioned in this document. MOU shall be executed by KRCL with successful / shortlisted companies / form under this EOI.
- ii. For each project / business identified, KRCL will associate with the most suitable firm / companies.
- iii. In case there are more than one willing, suitable firms / Companies for any project, KRCL will adopt competitive bidding or any other suitable criteria for identifying of most suitable firm / Company
- iv. Specific Agreements for each project will be signed subsequently with the successful bidders..

7.0 Validity of Agreement:

This Agreement shall be valid for a period of Three (3) years from the date of execution of this Agreement, and will be subject to extension on mutual agreement in writing between the Parties.

8.0 Termination, Determination, Cancellation of Agreement:

- 1. This Agreement shall commence on the date of its execution and shall continue in effect until the expiry of the period agreed.
- u. KRCL reserve the right to terminate this Agreement, in the following events -
- a) Breach of any statutes, laws, regulations, rules, directions of any Statutory Authority by Registered vendor/s ;
- b) Any violation of the terms and conditions of this Agreement by Registered vendor/s.
- c) In the public interest.

This Agreement shall stand automatically determined and discharged upon expiry of the period of this Agreement of Three (3) years, or any extended period.

In the event of termination, and/or determination of this Agreement, as mentioned under Clause 8(i) to 8 (ii) hereinabove, the Parties shall be responsible and liable to fulfill their respective obligations under the terms of this Agreement, prior to such termination, and/or determination.

9.0 Right to Change:

KRCL may at any time during the period of engagement, by a written order given to the Firms, make changes within the general scope of the engagement

10.0 Right to Accept/ Reject the Proposal:

KRCL reserves the right to accept and reject all Proposals at any time before the engagement of agencies, without thereby incurring any liability to the affected Bidder or Firms or any obligation to inform the affected Firms of the grounds for the KRCL action.

11.0 Clarifications:

When deemed necessary, KRCL may seek clarification on any aspect from the Bidder. However, that would not entitle the Bidder to change or cause any change in the substance of the Proposals submitted or the price quoted.

12.0 Clarification on this document:

A prospective Bidder requiring any clarification of the Bid Document may notify KRCL in writing at KRCL's mail address i.e. <u>sme.shubham@krcl.co.in</u>.

13.0 Language:

The Application and all related correspondence and documents shall be in English language. Supporting documents and printed literature furnished by the Applicant with the Application may be in any other language provided that they are accompanied by translations of all the pertinent passages in the English language, duly authenticated and certified by the Applicant. Supporting materials, which are not translated into English, may not be considered. For the purpose of interpretation and evaluation of the Application, the English language translation shall prevail.

14.0 Pre-submission meeting:

- i. - ii. The purpose of the meeting is to clarify the queries of the applicant/s.

- a. Minutes of the meeting, including the text of the questions raised (without identifying the source of query) and the responses will be uploaded on the same website on which the Registration / Shortlisting documents are uploaded.
- b. If required, a corrigendum to Registration / Shortlisting documents will be issued based on the decisions taken by Konkan Railway Corporation Limited in the pre-submission meeting and will be uploaded on the same website and the same shall become the integral part of the Registration / Shortlisting document.
