**Sub:** Provisional Panel for the post of Points Man and Track Maintainer-IV against notification no. CO/P-R/01/2024 dated 16/08/2024.

- 1) Konkan Railway Corporation Limited (KRCL) vide its notification no.CO/P-R/01/2024 dated 16/08/2024 have issued Employment notification for filling up posts in various categories including vacancies in Erstwhile Group-D posts i.e. Points Man and Track Maintainer – IV.
- 2) Based on Computer Based Test (CBT) result, document verification, on qualifying in Physical Efficiency Test (PET), post preference and number of community wise vacancies notified, provisional eligible candidates as per merit were called for Medical Examination for the post of Points Man. Consequent upon passing the requisite Medical examination, provisional Panel of successful candidates for the post of Points Man is notified as follows:

**Points Man:** In this Panel, against notified 60 (UR-31, EWS-6, OBC-NCL-5, SC-12, ST-6) vacancies, 16 (UR-2, OBC-NCL-5, SC-5, ST-4) candidates are provisionally empanelled. Panel will remain live for two years. The provisional Panel for the post of **Points Man** is attached as **Annexure-A**.

Since, no any candidate available to keep on the panel of Track Maintainer-IV, no panel will be issued for Track Maintainer – IV category.

- 3) The Panel of successful candidates is only provisional. Roll numbers are arranged vertically in descending order and not as per merit.
- 4) While due care has been taken in preparing the Panel, in case of any inadvertent error/s is noticed at any stage, KRCL reserves the right to rectify the same at later stage of selection procedure.
- 5) KRCL reserves the right to declare any candidate unsuccessful or delete his/her name from the notified provisional Panel at any stage of the selection procedure, if any discrepancy or malpractice is noticed or brought to the notice of KRCL at any stage. The decision of KRCL in the matter shall be FINAL.
- 6) KRCL will not entertain any individual queries in this regard.
- 7) For any legal dispute, the jurisdiction will be Hon'ble High Court, Mumbai only.
- 8) This empanelment is subject to the result of Writ Petition No.8675/2025(S-RES) filed by Sh. Vasundhara, S/o Nagendra Rao before the Hon'ble High Court of Karnataka at Bengaluru.
