The Provisional result of Computer Based Test (CBT) held from 13/01/2025 to 16/01/2025 against Notification No. CO/P-R/01/2024 dated 16/08/2024 has been published on 28/02/2025.

As mentioned in the notification, provisionally eligible candidates have been called for further selection process.

## 1) Document Verification (DV).

Provisionally eligible candidates have been called for DV as per their preference for the post for the respective PML and post in the order of merit, equal to the number of posts. Preferences given to candidates as mentioned in the notification. Further, an additional 30% of candidates as Standby candidates, over and above the number of vacancies, also being called for DV for the respective pay level and post. However, these standby candidates will be considered for empanelment only if there is a shortfall from the merit list or as a replacement against the shortfall because of non-joining recommended candidates in the working post or/and any other special requirements. - 7) For any legal dispute, the jurisdiction will be Hon'ble High Court, Mumbai only.


