I) Particulars of Organization, Functions and Duties			
Overview			
	KONKAN RAILWAY CORPORATION LTD (KRCL) was incorporated on 19.07.1990 pursuant to an Agreement between Government of India acting through Ministry of Railways and the Governments of Maharashtra, Goa, Karnataka and Kerala and obtained Certificate of Commencement of Business on 20.08.1990 for construction and operation of the Konkan Railway, a Broad Gauge Railway Line along the west coast of India connecting Roha (in Maharashtra, near Mumbai) in the North to Thokur, (Near Mangaluru, Karnataka) in the South and for raising the necessary finance for the project from the market. The Project was envisaged under the BOT (Build-Operate-Transfer) concept for the first time in India. The line was commissioned on 26.01.1998.		
Infrastructure Works			
	• Doubling: Konkan Railway has commissioned the double line between Roha & Veer for passenger traffic on 30.08.2021.		
	• Electrification: Electrification of complete KR Route has been completed dedicated to the Nation by the Hon'ble Prime Minister on 20.06.2022.		
	• Infrastructure Augmentation: To increase the capacity of the Section, 10 additional crossing Stations and 10 new loop lines have been added during the last five years.		

The Corporation has also undertaken the following other activities in terms of the objectives:

- **Tunnels:** Owk tunnel in Andhra Pradesh, Jawahar Tunnel in Jammu & Kashmir and 11 tunnels of Mumbai-Pune Express Highway were successfully executed.

- **ROB:** Construction of 14 Road-over Bridges in Jharkhand State have been completed.

- **Udhampur – Srinagar- Baramulla Rail Link Project is a National Project.** A part of this project from Katra-Dharam 52.2km has been assigned to Konkan Railway Corporation Ltd. for execution. It comprises of 44.59 km (86%) of route in tunnels, 4.6 km (8.6%) of route on bridges & balance 3.01 km of route in cuttings and embankments including two iconic bridges across river Chenab (Arch Bridge) and at Anji Khad (Cable stayed). The work has been completed and this section was dedicated to the Nation by the Hon'ble Prime Minister on 06.06.2025.

- **Siding** - MRPL, Mangalore: Works Completed, siding facilitate movement of various commodities like pet coke, sulphur, bitumen, polypropylene etc.
Multimodal Logistic Park Balli - This siding facilitate movement of containers.

- **NTPC Railway Siding Project:** NTPC has awarded KRCL the work of preparation of Detailed Project Report and Construction of Coal Transportation System for Kudgi Super Thermal Project in Karnataka State and Rail Connectivity for Super Thermal Power Plant at Gadawara, Madhya Pradesh was also awarded to KRCL under Project Management Consultancy Contract (PMC). Work has already been completed.

- **Rolling Stock Component Factory at Lote, Ratnagiri:** A Central Railway Project, being executed by KRCL. RSCF shall be a Nodal Centre for supply of Critical Safety components as Unit exchange spares for freight wagons and coaches of Mail Express trains etc. Project is in completion stage.

Thalassery to Mysuru New Railway line: Kerala Rail Development Corporation Limited (KRDCL) has entrusted the work of preparing Feasibility Study Report and Detailed Project Report to KRCL for the proposed Thalassery – Mysuru new Railway line. The project is being executed in two stages, i.e. Thalassery to Minangadi as Phase-I in Kerala State (103.64 Kms) and in the remaining portion from Minangadi to Kadakola as Phase-II in Karnataka State. The Final Location Survey and Geotechnical investigation from Thalassery to Minangadi of 103.64 RKM has been completed. The Aerial Electromagnetic (AEM) Survey from Thalassery to all tunnel locations has been completed. DPR for Phase-I from Thalassery to Minangadi was submitted to KRDCL. Based on the observations of KRDCL, DPR in revised proforma is submitted.

- **Anakkampoyil-Kalladi-Meppadi Road Tunnel Project:** Government of Kerala has assigned KRCL as Special Purpose Vehicle (SPV) for the execution of the Anakkampoyil-Kalladi-Meppadi Road Tunnel Project. A Tripartite Agreement has been signed between Konkan Railway, Public Works (H) Department and Kerala Infrastructure Investment Fund Board (KIIFB) to implement the project. KRCL has prepared DPR for Twin Tube unidirectional Tunnel with 4 lane approach road and two parallel major bridges at southern end. Administrative sanction for DPR from Government of Kerala has been received. Comprehensive Environmental Study completed, Land acquisition and Tender process are in progress.

- **Rail Connectivity To Vizhinjam International Sea Port, Kerala:** MOU has been signed between KRCL and Vizhinjam International Seaport Ltd (VISL) to link the Vizhinjam Seaport (11 km). The Detailed Project Report (DPR) has been approved by Southern Railway under NGR model. Administrative sanction by Govt. of Kerala for DPR has also been accorded. Land acquisition for the project is in progress.

- **ECoR Works:** East coast Railway has awarded the work of Construction of Viaduct, Major Bridges, ROBs and other alight works of Khurda Road – Bolangir new BG Rail Link Project to Konkan Railway. Work is in progress.

- **North Western Railway Work:** North Western Railway has awarded the work of execution of new BG line in Ajmer Division (23.65 km). Work is in progress.

- **Electrification work:** Konkan Railway has undertaken Railway electrification works in various zonal Railways and other electrification work in State Govt. Works are in progress at various locations.

Technologies

The following technologies were conceptualized and developed by the Corporation.

- **Automated Train Examination Systems (KR-ATES):** KR-ATES is a Way Side Equipment (WSE) being fully conceptualised and designed by a team of Konkan Railway to detect various defects in rolling stocks of moving trains which pass through it and provide an immediate alert to avoid unusual and accidents.

Konkan Railway has been **granted patent by Government of India for this innovative technological**

- **New Automatic Coach Washing Plant of KRCL Design:** ACWP is a multistage external cleaning system for train coaches, within 15 minutes. ACWP also cleans the area of coach below the toilets which is otherwise not cleaned manually. Water used for washing coaches is treated and recycled & reused.

- **Boulder Netting & Geo Netting:** Konkan Railway engineers have introduced indigenously developed Boulder Netting and geo-netting to prevent boulder falls or soil slippage on railway tracks in cutting along its route, thus enhancing safety.

- **RO – RO (Roll – on Roll – off):** Scheme was started on 26th January 1999, which has enabled carrying loaded trucks directly on the railway wagons for reducing the expenditure on Diesel, wear and tear of tyres, and maintenance of trucks for the Truck Operators.

- **Information Technology:** is one mainstay of Konkan Railway's working. IT has helped Konkan Railway become & remain efficient and lean. It supports all aspects of KR's working, through various modules of ERP, integrated in Railway Applications Package, a first and still unparalleled in IR.

International Projects:

- Konkan Railway has completed the order for supply of 2 DEMU rakes to Nepal Railway. Report submitted to MEA & RB on 24/03/2023. East Central Railway, vide LOA dated 13.03.2020 have awarded Final Location Survey for new BG Line between Raxaul and Kathmandu. Konkan Railway submitted the report to MEA & RB on 24/03/2023.
- The Operation & Maintenance support Jaynagar-Kurtha section of Nepal Railway line is being done by KRCL. The inauguration of passenger services was done by the Hon'ble Prime Ministers of India and Nepal on 02.04.2022.
- KRCL has signed a contract with M/s. Tata Chemicals Limited, Magadi, Kenya in December 2022 for Rehabilitation of Railway Systems.
