- 1) Konkan Railway Corporation Limited (KRCL) vide its notification no.CO/P-R/01/2024 dated 16/08/2024 have issued Employment notification for filling up posts in various categories including Goods Train Manager.
- 2) Based on Computer Based Test (CBT) result, post preference and number of community wise vacancies notified, provisional eligible candidates as per merit were called for Document verification and Medical Examination for the post of Goods Train Manager. Consequent upon qualifying in Document verification and passing the requisite Medical examination, provisional Part Panel-I of successful candidates for the post of Goods Train Manager is notified as follows:  
  
**Goods Train Manager:** In this Panel, against notified 05 (UR-03, SC-01, ST-01) vacancies, 04 (UR-02, SC-1, ST-1) candidates are provisionally empanelled. On finalisation of entire selection process, final empanelment along with proper Roster category will be issued. Panel will remain live for two years. The provisional Panel for the post of Goods Train Manager is attached as **Annexure-A**.
- 3) The Panel of successful candidates is only provisional. Roll numbers are arranged vertically in descending order and not as per merit.
- 4) While due care has been taken in preparing the Panel, in case of any inadvertent error/s is noticed at any stage, KRCL reserves the right to rectify the same at later stage of selection procedure.
- 5) KRCL reserves the right to declare any candidate unsuccessful or delete his/her name from the notified provisional Panel at any stage of the selection procedure, if any discrepancy or malpractice is noticed or brought to the notice of KRCL at any stage. The decision of KRCL in the matter shall be FINAL.
- 6) KRCL will not entertain any individual queries in this regard.
- 7) For any legal dispute, the jurisdiction will be Hon'ble High Court, Mumbai only.
