

RO-RO (Roll-on Roll-off) Services for Transportation of Cars from Kolad to Nandgaon & Verna and from Verna & Nandgaon to Kolad

Instructions for Users:

In line with Konkan Railway Corporation Limited's continued commitment to provide innovative and customer-centric freight services, it has been decided to introduce **Ro-RO services for the transportation of cars between Kolad (Maharashtra) to Nandgaon Road (Maharashtra) and Verna (Goa)**, as per the following terms and conditions:

1. **Route and Schedule:** - The services will be available between the following stations with enroute unloading/loading halt at Nandgaon Road.
 - a. Kolad to Nandgaon Road
 - b. Kolad to Verna
 - c. Nandgaon Road to Kolad
 - d. Verna to Kolad

The time of departure and arrival for the RORO service will be as under

2. **Operations of RO-RO Services:** The maximum capacity per trip will be 40 cars. The rake will have a composition of 20 wagons, and each wagon will be loaded with two cars. **In the event, the booking is less than 16 cars per trip, the services will be cancelled.** In such event, the registration fee paid by the customer will be refunded by Konkan Railway Corporation Limited.

3. **Booking Procedure:**

- a. The freight charges per car will be as under:
- i. Kolad- Verna: Rs.7875/- (including 5% GST) in each direction.
 - ii. Kolad- Nandgaon Road : Rs.5460/- (including 5% GST) in each direction.
- b. The willing customers shall prebook their slots by paying a registration fee of Rs.4000/- (including 5% GST) at the address and during the stipulated time. The balance amount shall be paid on the Day of journey at originating station. (i.e. Kolad, Verna or Nandgaon Road as the case may be)
- c. **Registration:** The customers willing to avail the services shall book the car by paying registration charges of Rs.4000/- per car (including 5% GST) at the address and during the timings given below:

- d. Booking for all the trips will remain open up to **17:00 hrs on 20/08/2025.** (On working days ie from Monday to Friday)
- e. Mode of payment: The payment for registration will be accepted through UPI or cash. At stations, the balance freight can be paid by the customer in cash, UPI or through credit/debit cards.

- f. While registration, details of the car i.e. registration number, copy of RC book, signed registration form and at the station a self-declaration form in the prescribed format shall be submitted by the customer.
- g. On the day of the journey, the customer shall report three hrs in advance before the departure time and pay balance amount of freight at the station. In the event of customers not turning up, the registration charges will be forfeited.
- h. The customer shall sign and submit the declaration form/ Indemnity form at the station.
- i. The customer shall declare the details of accompanying passengers on the reservation form and obtain a journey ticket by paying the prescribed fare. A maximum of three persons (pax) per car will be allowed to travel in passenger coach attached with the RORO train on payment of prescribed fare. Two passengers shall be allowed to travel in 3AC coach and one passenger will be allowed to travel in SLR (2S) coach. The prescribed passenger fare shall be as under:
 - i. **Kolad – Nandgaon Road:**
3AC : Rs.690/- per pax; 2S: Rs.140/- per pax.
 - ii. **Kolad - Verna:**
3AC – Rs.935/- per pax; 2S-Rs.190/- per pax
- j. Journey Ticket for pax will be issued at Kolad / Verna / Nandgaon road station manually (EFT). The EFT should be cross referenced by journey ticket issued for cars.

4. Cancellations and Refund

- a. Each trip has the capacity to carry 40 cars. **In the event, the booking is less than 16 cars per trip, the services will be cancelled.** In such event, the registration fee paid by the customer will be refunded by Konkan Railway Corporation Limited.
- b. No cancellations are permitted once the services are booked. In case, trips are not operated by KRCL, refund of the registration fee paid by the customer will be refunded in the bank account provided by the customer at the time of booking.

5. Terms and Conditions

- a. Customers shall note that they will be availing this facility at their own choice and risk.
- b. The customer along with his car and accompanying passengers shall report at the starting station at least 3 hrs before departure of the RORO train.

- c. The driver and accompanying passengers shall travel in the passenger coach attached to the train by paying prescribed fare for the applicable class.
- d. A maximum of 3 passengers (2 pax in 3AC coach and one pax in SLR(2S)) will be permitted against each car booking. Details of the passengers i.e. Name, Age, Sex shall be declared by the customer. Additional passengers, if any, will be permitted only if there are vacant berths in the coach, at sole discretion of KRCL.
- e. Loading (Rolling On) and unloading (Rolling off) of cars from the RORO train shall be the responsibility of the customer. Required assistance shall be provided by Konkan Railway Corporation Limited.
- f. The cars loaded on the train will be secured with the lashing belts.
- g. The customer shall ensure that once cars are loaded on the train, the hand brakes are applied, and doors are closed & locked properly.
- h. The customer shall ensure that no unlawful, inflammable material is carried in the car.
- i. In any circumstances, customer will not travel in the car loaded on the RORO train, during the transit. It may please be noted that RORO train is moving on the electrified section, and the OHE is charged with 25 KV supply which is potentially dangerous to human life.
- j. In the event of cancellation of the services, no claim other than refund of the charges paid by customers will be entertained by KRCL.
- k. Customers shall ensure that there are no loose articles like decorative material / ropes / antenna etc attached to the vehicle.
- l. Konkan Railway shall not be responsible for any damage to the car/ theft of articles kept in the car. The customer shall indemnify Konkan Railway Corporation Limited for any injury sustained on self or any damage to the vehicle or articles kept in the vehicle.

- (ii) A copy of PAN Card
- (iii) A copy of RC Book/Card of the Car
- (iv) A copy of Valid Insurance of the car

11. I understood the precautions to be taken during the journey as explained to me. I indemnify Konkan Railway Corporation Limited for any injury sustained on self or any damage to my vehicle or articles kept in the vehicle.
