Invitation of "Expression of Interest" for the association as Project Partners with Konkan Railway Corporation Ltd for Operation and Maintenance of Railways / Monorail / Metro / Loco Shed / Workshop

1.0 General:

- 1.1 The Konkan Railway Corporation Ltd. (KRCL) is a Company incorporated under The Companies Act, 1956 and having its Registered Office at Belapur Bhavan, Plot No.6, Sector 11, CBD Belapur, Navi Mumbai-400614, India and has constructed the 739 kms long Konkan Railway Line along the west coast of India and is operating train services on the line since the year 1998. KRCL is a Public Sector Undertaking (PSU) under the Ministry of Railways established with equity participation of Government of India (69.76%) along with four State Governments Maharashtra (15.47%), Karnataka (10.55%) and Kerala (4.22%) for construction and operation of west coast Railway line.
- 1.2 KRCL is engaged in implementation of Infrastructure projects in India and abroad. The important projects on which KRCL is presently working are:
 - i) Construction of new BG Rail line in the Katra-Dharam Section of the Udhampur-Srinagar- Baramulla Rail Link Project in Jammu & Kashmir.
 - ii) Construction of Coal Transportation system including associated Electricals Package NTPC Gadarwara STPP, Stage I.
 - lii) Rail connectivity to Vizhinjam International Seaport.
 - iv) Anakampoyyil Kalladi Meppadi Tunnel Road in Wayanad, Kerala.
- 1.3 Besides implementation of above infrastructure projects, KRCL is also engaged in providing services of Train Operation, Station Control and other technical O&M activities in Maha-Metro on outsourced basis for the Operation & Maintenance of Navi Mumbai Metro Line-1 project (for Three Years).
- 1.4 Further, KRCL is actively looking to expand its footprints across the country.

- 1.5 KRCL invites Expression of Interest from Companies/Firms involved in providing services for:
 - (i) Operation and Maintenance of Electrical Systems.
 - (ii) Operation and Maintenance of Mechanical Systems.
 - (iii) Operation and Maintenance of Signal & Telecommunication Systems and IT systems.
 - (iv) Operation and Maintenance of Civil Engineering systems.
 - (v) Operation and Maintenance of Complete Systems of Electrical, Mechanical, Signal & Telecommunication, IT, Civil, Key personnel provision other associated works, etc.

2.0 Expression of Interest (EOI):

- 2.1 The "Expression of Interest" is invited from experienced and reputed Companies/Firms with proven financial standing and experience in following domain.
 - Based on the response to the "Expression of Interest", KRCL will short-list the Firms/Companies in the domains of expertise of the Applicants. MoU shall be executed by KRCL with successful / shortlisted companies /firms under this EOI.
 - For each project / business identified, KRCL will associate with the most suitable, willing Firm/Company from amongst the short-listed Firms/Companies meeting the eligibility criteria jointly with KRCL for identified project for further exploration of project/business.
 - In case there are more than one willing, suitable Firms/Companies for any project, KRCL will adopt competitive bidding or any other suitable criteria for identifying of most suitable Firm/Company.
 - Specific Agreements for each project will be signed subsequently with the successful Bidders.

- **2.3** Shortlisting of the Company/ Firm will be valid for a period of three years from the date of intimation of the shortlisting by KRCL.
- 3.0 In addition to the terms of the MoU executed between KRCL and the successful / shortlisted Companies/Firms, the Scope of work of Successful / Shortlisted Companies / Firms shall include the following:
 - (i) The companies/firms will associate for pre-tender activities like survey, estimation and any other assistance required to KRCL for preparation of techno-economical costing.
 - (ii) Supply, installation, testing, and commissioning of equipment and requisite materials at site.
 - (iii) Ensuring timely installation and commissioning immediately upon delivery and site readiness, to enable project completion within schedule and to safeguard warranty obligations.
 - (iv) Operation and Maintenance (O&M) of the installed systems/equipment for the agreed duration, including deployment of trained manpower, supply of spares/consumables, preventive and corrective maintenance, and ensuring minimum downtime in line with the terms of the MoU/tender.

4.0 Documents for Eligibility:

- b. Of turnover of the Company/Firm in the preceding three financial years.
- c. Companies/Firms should also have experience of having successfully executed at least 1 (one) works in the last 7 (seven) years in the domain of Railways / Monorail / Metro / Loco Shed / Workshop, which may include activities related to Operation, Maintenance, Construction, Commissioning, Electrification or other associated works.
- d. Companies/Firms shall submit documentary proof issued by the respective clients (in original or notarized) in support of their credentials.

KRCL shall reserve the rights to decide the criteria for different categories/classes depending on the value of the projects completed and experience possessed.

(II) Operation & Maintenance of Railways / Monorail / Metro / Loco Shed / Workshop which includes Mechanical & associated works.

Eligibility:

The Companies/Firms must submit documents in proof:

- a. Of having successfully executed and/or commissioned works related to Railways / Monorail / Metro / Loco Shed / Workshop in India during the last 07 (seven) years, ending last day of the month previous to the one in which the EOI is invited/submitted. The works may include construction, commissioning, mechanical works or other allied activities.
- b. Of turnover of the Company/Firm in the preceding three financial years.
- c. Companies/Firms should also have experience of having successfully executed at least 1 (one) works in the last 7 (seven) years in the domain of Railways / Monorail / Metro / Loco Shed / Workshop, which may include activities related to Operation, Maintenance, Construction, Commissioning, Mechanical or other associated works.
- d. Companies/Firms shall submit documentary proof issued by the respective clients (in original or notarized) in support of

their credentials.

- b. Of turnover of the Company/Firm in the preceding three financial years.
- c. Companies/Firms should also have experience of having successfully executed at least 1 (one) works in the last 7 (seven) years in the domain of Railways / Monorail / Metro / Loco Shed / Workshop, which may include activities related to Operation, Maintenance, Construction, Commissioning, Signaling & Telecommunication or other associated works.

- b. Of turnover of the Company/Firm in the preceding three financial years.
- c. Companies/Firms should also have experience of having successfully executed at least 1 (one) works in the last 7 (seven) years in the domain of Railways / Monorail / Metro / Loco Shed / Workshop, which may include activities related to Operation, Maintenance, Construction, Commissioning, or other associated works in civil engineering.
- d. Companies/Firms shall submit documentary proof issued by the respective clients (in original or notarized) in support of their credentials.

KRCL shall reserve the rights to decide the criteria for different categories/classes depending on the value of the projects completed and experience possessed.

(V) Operation & Maintenance of Railways / Monorail / Metro / Loco Shed / Workshop which includes Complete Systems of Electrical, Mechanical, Signal & Telecommunication, IT, Civil Engineering, and Key personnel provision for other associated works, etc.

Eligibility:

The Companies/Firms must submit documents in proof:

- a. Of having successfully executed and/or commissioned works related to Railways / Monorail / Metro / Loco Shed / Workshop in India during the last 07 (seven) years, ending last day of the month previous to the one in which the EOI is invited/submitted. The works may include construction, commissioning, electrification, signaling, depot works, track laying, station development, or other allied activities.
- b. Of turnover of the Company/Firm in the preceding three financial years.
- c. Companies/Firms should also have experience of having successfully executed at least 3 (Three) works in the last 7

(seven) years in the domain of Railways / Monorail / Metro / Loco Shed / Workshop, which may include activities related to Operation, Maintenance, Construction, Commissioning, Electrification, Signaling & Telecommunication, Civil Engineering, or other associated works.

d. Companies/Firms shall submit documentary proof issued by the respective clients (in original or notarized) in support of their credentials.

KRCL shall reserve the rights to decide the criteria for different categories/classes depending on the value of the projects completed and experience possessed.

5.0 For avoidance of doubt, it is clarified that:

- a) Shortlisted Business Associates may directly enter/undertake any transaction through itself outside this EOI; except for the projects jointly identified with KRCL, for which any bidding/participation/transaction shall be done jointly with KRCL only.
- b) For project not jointly identified with any business associates, KRCL may directly enter/undertake any transaction through itself or through its Group outside this EOI.
- c) However, in respect of the following, no party shall individually on its own or in association with some other third party entity, proceed to further explore and/ or implement, with or without modifications, any project or investment opportunity:
 - Which has been jointly identified and/or agreed to be explored jointly by the parties, or
 - Which has been identified by one party and introduced to the other party and agreed to be further explored jointly by the parties, or
 - Which has been awarded or being contemplated to be awarded to the parties, for joint exploration and/ or implementation, by any third party entity, whether public or private.

Unless:

 The Parties agree in writing to take up and keep the said opportunity outside the scope of the EOI.

- One Party (Non-Pursuing Party) gives its consent, in writing, to the other
 Party to pursue and further explore the said opportunity, individually or in
 association with any other entity at its own cost & expense, outside the
 purview of this EOI.
- 6.0 Submission of EOI: The interested Companies/Firms are requested to submit its credentials including past experience of executing the similar works, Company/Firms financial status, organizational setup available with Company/Firm etc., in the EOI format enclosed so as to reach the office of Chief Electrical Engineer/KRCL, Belapur Bhavan, 3rd Floor, P.B.
