2) Provisional result of Computer Based Test (CBT) published on 28/02/2025.

The Provisional result of Computer Based Test (CBT) held from 13/01/2025 to 16/01/2025 against Notification No. CO/P-R/01/2024 dated 16/08/2024 has been published on 28/02/2025.

As mentioned in the notification, provisionally eligible candidates are being called for further selection process.

1) Document Verification (DV).

Provisionally eligible candidates are being called for DV as per their preference for the post for the respective PML in the order of merit to fill up remaining posts. Further, additional candidates as notified as Standby candidates, over and above the number of vacancies, are also being called for DV for the respective pay level and post. However, these standby candidates will be considered for empanelment only if, there is a shortfall from the merit list or as a replacement against the shortfall because of non-joining recommended candidates in the working post or/and any other special requirements subject to qualifying in DV, Medical examination etc.

List of candidates being called for document verification for the post of Technician-III/Electrical and Technician-III/Mechanical is enclosed as Annexure- A and Annexure-B.

2) Medical Examination.

Candidates who will qualify in DV will be further sent to Medical examination as per merit for above mentioned posts. Medical examination may take time of few days. Hence, candidates are advised to come with preparedness for the same. The candidates will have to bear the cost of medical examination, as this is initial recruitment medical examination. Only fit candidate will be considered for empanelment against notified posts as per their preference and CBT subject to availability of vacancies.

- 3) No request for change of date of Document verification will be entertained.
- **4)** While due care has been taken in preparing the list, in case of any inadvertent error/s is noticed at any stage, KRCL reserves the right to rectify at later stage of selection procedure.
- 5) This is only the provisional list for DV and NOT the FINAL PANEL and it does not entitle any candidate for appointment.
- 6) KRCL reserves the right to declare any candidate unsuccessful or delete his/her name from the notified result / panel at any stage of the selection procedure, if any discrepancy or malpractice is noticed or brought to the notice of KRCL at any stage. The decision of KRCL in the matter shall be FINAL.
