### **About Vigilance**

The Vigilance is an integral part of the Management function. The Vigilance dept. at Corporate Office, Belapur handles all vigilance matters pertaining to the Corporation. We believe that with best practices, appropriate control and transparency in place, informed and professionally right decisions can be taken efficiently, effectively and consistently, for good corporate governance.

Vigilance department is headed by Chief Vigilance Officer (CVO) who is assisted by a Deputy Chief Vigilance Officer and an Senior Vigilance Officer. The Vigilance department arranges vigilance seminars / training programmes for the benefit of the employees of Konkan Railway.

The CVO, on the basis of the investigations carried out, provides advice to the Management to bring about qualitative improvement in the functioning of the Corporation. The CVO is also a link between the Corporation and agencies like Central Bureau of Investigation (CBI), Central Vigilance Commission (CVC), Railway Board etc. on vigilance matters and also for sharing of the system improvements suggested and implemented in the Corporation.

The major function of the department comprises of investigation of complaints received from various sources, preventive vigilance like surprise inspections, regular surveillance/scrutiny of procurement and contract matters, matters related to Chief Technical Examiner's (CTE) intensive examination reports, coordination with the Central Bureau of Investigation (CBI), Ministry of Railways, etc.

### **Objectives**

Vigilance department has following objectives:

1. Minimise corruption and malpractice.
2. Institute preventive vigilance
3. Suggestions/recommendations to the Management to develop and improve upon systems and procedures.
4. Help in bringing about change in work culture and work ethics.
5. Create vigilance awareness amongst the employees.
6. Help to develop transparency in work.
