Part - II

Instructions to the Applicants

1 Scope of the contract:

The Marketing Agent shall market the RORO services and attract the truckers for booking through existing RORO services from Kolad and Surathkal stations over Konkan Railway.

2 General Instructions:

- 2.1 The applicant may be individual, Firm, Partnership or a Company having business operations in the field of transportation of goods by road.
- 2.2 Application form is not transferable.
- 2.3 Applicant can apply for any one location (i.e. Kolad and Surathkal) or both the locations. However, separate applications are to be made for each location.
- 2.4 All documents submitted should be serially numbered on the top right corner of every page.
- 2.5 The applications received will be evaluated in accordance with the eligibility criteria mentioned in the terms and conditions for appointment of Marketing Agents for booking trucks through RORO service. Shortlisted applicants may be required to appear for personal interview with original documents/ certificates before the committee nominated for evaluation of the applications. KRCL will not reimburse any expenses on this account.
- 2.6 Decision taken by the KRCL in awarding the contract will be final and binding on all. No correspondence, whatsoever will be entertained in this regard.
- 2.7 Canvassing of any kind will disqualify the applicant.
- 2.8 If an applicant expires or the firm / partnership / company dissolves after submission of application or after the acceptance of his offer, such application shall stand cancelled.
- 2.9 The applicant shall obtain necessary permits as required under law in operation from time to time, the applicant shall always be liable to ensure due compliance/observance of labour laws and other State/Central laws as applicable.

TERMS AND CONDITIONS FOR APPOINTMENT OF MARKETING AGENTS FOR BOOKING TRUCKS THROUGH RORO SERVICE.

1 Eligibility Criteria

- 1.1 The applicant should have office or table space located in the vicinity of Kolad / Suratkal station OR in the catchment area of the RORO service. The catchment area for the RORO traffic originating from Surathkal shall be Surathkal, Majeshwar, Mangalore and Kerala state. Whereas the catchment area for the RORO traffic originating from Kolad shall be Kolad, Raigad District, Thane District, Navi Mumbai / Mumbai / South Mumbai / Bhivandi area, Gujarath and Rajasthan state. Documentary proof for the address of the office premises / space should be attached.
- **1.2** The applicant should have relevant experience fleet as а commercial owner/transporter/commission agent for heavy vehicles (trucks/trailers/tankers/tempos) (Documentary proofs clearly stating the number of years of experience should be attached).
- **1.3** The applicant should have minimum turnover of Rs.10 lakhs in each of last two financial years i.e. FY 2023-24 and FY 2024-25. (Copy of PAN CARD, Audited balance sheet, and income tax returns for the past two years i.e. 2023-24 and 2024-25 should be attached).

2 Submission of Application form

- **2.1** Applicants shall submit the application in the prescribed format duly signed.
- **2.2** All the documents including application form, terms and conditions and enclosures should be signed and stamped by the applicant on each page.
- 2.3 In case of applicant being individual or sole proprietor firm, the applicant should attach the character certificate issued by the Gazetted Officer / Police Authority not below the rank of Circle Inspector.
- **2.4** The application is liable to be rejected in case of non-submission of the prescribed documents sought for.
- 2.5 KRCL reserves the right to seek additional information / documents for clarification / supplementary nature from the applicants after opening of applications, if found necessary, during the course of evaluation of the offer. Non-submission or delayed submission of such information / documents sought by KRCL as mentioned hereinabove shall be ground for rejecting the offer/proposal. The decision of the KRCL in this regard shall be final and binding upon all the applicants.
- **2.6** The KRCL reserves the right to reject any or all applications without assigning any reason.

3 Security Deposit:

3.1 The applicant shall be liable to deposit an amount of ₹ Rs.1,00,000/- (Rs.One Lakh only) towards Security Deposit in the form of Cash/RTGS/NEFT/Demand Draft issued by any Nationalized / Scheduled Bank in favour of "Konkan Railway Corporation Ltd." Payable at CBD Belapur, Navi Mumbai-400614 on appointment as Marketing Agent. The Security Deposit will not carry any interest and will be refundable after deducting dues, if any, at the end of the contract period.

4 No. of Marketing Agents to be appointed:

- **4.1** Upto 4 (Four) Marketing Agents shall be appointed for each station. (i.e. for Kolad and Surathkal). Interested applicants may apply for a single location as well as both locations (i.e. Kolad & Surathkal) separately.
- **4.2** KRCL reserves the right to appoint more than 4 (Four) marketing agents or additional agents at any time during the currency of contract.

5 Selection process for Agents (Evolution of offers):

5.1 The ranking for the applicants shall be done on the basis of marks received out of 100 as below -

- **5.2** The Minimum qualifying marks are 60.
- **5.3** In case of more than 4 applicants with marks above 60, top 4 applicants shall be selected for each location in the order of ranking based on marks obtained.

6 Validity of the Contract:

6.1 This appointment of Marketing Agent shall be valid for a period of three months from the date of signing the agreement and may be extended further upto three months on one month at a time, based on requirement of KRCL and performance of the marketing agent.

7 Infrastructure and manpower:

- **7.1** KRCL shall not provide any place for office in railway premises to marketing agent or his agent, administrators or assigns.
- **7.2** KRCL reserves the right to forfeit the security deposit if the registration is canceled for the breach of any terms of conditions mentioned herein.
- **7.3** The marketing agent will not be allowed to carry any other business in the Railway premises except that in connection with booking of trucks in RORO service.
- **7.4** The marketing Agent will furnish the list of his employees with Identity cards & verified signatures of employees engaged by him in connection with booking/marketing of RORO service.
- **7.5** No person other than authorized by KRCL will be permitted to enter in the Railway premises.

8 Booking of Trucks:

- **8.1** Trucks with dimensions and weight as permitted on RORO service only shall be booked by the agency.
- **8.2** KRCL reserves the right to book the trucks for RORO service offered by truckers/traders directly to KRCL.
- **8.3** The trucks for RORO service will be booked on first come first basis and Marketing Agents will not have any preference in booking of trucks for RORO service.
- **9 Proposed Commission:** The proposed commission for booking of trucks in RORO service on monthly basis as under:

Note: - The minimum benchmark no. of trips for the above criteria to be fulfilled shall be kept as 20 per month. If no. of trips from a location during any month is less than 20, the monthly criteria shall be revised on pro-rata basis for that location.

9.1 If an agent brings less than 400 trucks per month per location, he shall not be paid any commission amount, whatsoever, for that month.

10 Penalties:

10.1 Penalties for detention arising out of the truck booked by agent at the originating station:

Detentions that may arise due to reasons like tilting of consignment on truck, breakdown of truck, bursting / puncture of tyre of truck etc.

- **10.1.1 When empty rake is placed for loading:** Loading time shall be considered as two hours. If the loading time exceeds beyond two hours due to any of the reasons mentioned above, penalty of Rs.1000/- per hour shall be levied for excess time taken for loading of the rake beyond two hours.
- **10.1.2** If loaded rake is placed for unloading and not followed by loading: Unloading time shall be considered as one hour. If the unloading time exceeds beyond one hour due to any of the reasons mentioned above, penalty of Rs.1000/- per hour shall be levied for extra time taken for unloading of the rake beyond one hour.
- **101.3** If loaded rake is placed for unloading followed by loading: Loading / unloading time shall be considered as three hours. If the loading / unloading operation exceeds beyond three hours due to any of the reasons mentioned above, penalty of Rs.1000/- per hour shall be levied for excess time taken for loading/unloading operations of the rake beyond three hours.

11 Payment of Commission:

- 11.1 The marketing agent shall submit monthly bill alongwith summary of trucks (summary sheet detailing Date, Rake no., no. of BRNs, No. of trucks, weight of each truck) loaded trip wise to Station Manager. The bill shall be certified by Commercial Supervisor and forwarded by RTM/Sr. RTM (Regional Executives) to Corporate Office for further scrutinee and payments.
- **11.2** Payment will be made directly in name of the Marketing Agent through cheque or through Electronic Clearing System.
- **11.3** Recoveries towards penalties will be recovered from the monthly bill, if not paid at the stations.
- **11.4** The Marketing Agent shall be paid commission after deduction of the statutory taxes /levies as prescribed by law from time to time.
- **11.5** Details received from the marketing agent through email shall be tallied with the loading register records at station for trucks with manual booking, in addition to verification of the remaining trucks using system-generated report.

12 Other terms and Conditions:

- **12.1** KRCL reserves the right to appoint additional Marketing Agent/s for RO-RO service in addition to the Marketing Agent to be appointed under this notification for booking of trucks in RORO service.
- **12.2** In case of breach of any of the condition of the allotment by the Marketing agent, KRCL may debar him from functioning as Authorized Agent for booking of RORO services.
- **12.3** The contract will stand terminated on expiry of agreement period or extended period. The KRCL reserves the right to terminate the appointment at any time without assigning any reason, whatsoever, by serving 72 hours (3 days) notice.
- **12.4** The Marketing Agent will be responsible to compensate the cost of any damage/loss to Railway property/personnel if caused due to any act of omission or commission by him or his employees or truck drivers whether done negligently or otherwise.
- 12.5 KRCL will not be responsible for any injury to the Marketing agent or his employees if any occurred during the work related to booking of trucks in RORO service. The Marketing agent or his employees will not have any right to claim any compensation from the KRCL for any loss or damage of whatsoever nature if any occurred while performing work under this registration. The Marketing Agent will be solely responsible for any such injury occurred during the course of work under this agreement to him or his employees.
- **12.6** Nothing contained herein shall be construed as conferring upon the Marketing Agent any rights of any nature over the property of the KRCL/ or employment in the KRCL or shall be construed as partnership with KRCL.
- **12.7** The Marketing Agent shall in no way represent himself / itself nor permit any person / party acting on its behalf to represent himself / itself as a partner, franchisee, joint venture, employee, or representative of KRCL.
- **12.8** The KRCL reserves the right to review and revise the terms and conditions mentioned herein at any time during the contract period.
- 12.9 The KRCL reserves the right to revise RO-RO rates from time to time; such revised rates will also be applicable to booking of trucks by marketing agent from the effective date mentioned in the notification issued by KRCL. Any contravention of these terms, shall lead to cancellation of registration and forfeiture of Security Deposit.
- **12.10** There shall be no relation between the RO-RO rates and the commission amount payable to the marketing agent.
- **12.11** The marketing agent shall not quote any rates to the truckers other than those notified by the KRCL from time to time.
- **12.12** Any dispute of whatsoever nature arising between the marketing agent and the truckers shall be settled by the marketing agent keeping the KRCL indemnified at all the time.

- **12.13** KRCL reserves the right to reject any truck booked by marketing agent found to be unfit or dangerous to be carried on RO-RO service and in such case the Marketing agent shall be liable to pay a penalty to the KRCL as decided by the Competent Authority at that time.
- **12.14** KRCL reserves the right to weigh and reweigh the trucks brought by the Marketing agent before or after the transit and weighment or re-weighment done by KRCL will be final and binding on marketing agent for payment of freight charges and/or penalty as per extant Rules.
- **12.15** KRCL reserves the right to change the schedule of RO-RO service as and when deemed necessary and marketing agents or the truckers shall not be entitled for any damages or compensation on this account.
- **12.16** The marketing agents shall not be entitled to any reimbursement of traveling expenses /office expenses / telephone expenses etc. The marketing agents should bear the incidental expenses.
- **12.17** The commission is payable subject to deduction of income tax. The marketing agent is liable for service / professional tax etc.
 - **12.17.(a)** Any tax liability arising out of the business of RORO Marketing Agency, collection of freight from truckers shall accrue to the Marketing Agent and KRCL shall remain out of the purview of it.
- **12.18** The agreement will be executed between KRCL and the Marketing Agent and the terms and conditions of the agreement shall be binding on the Marketing Agent during the tenure of the contract.
- **12.19** The application for appointment of marketing agent shall be governed by all applicable laws in India and shall be subject to the jurisdiction of law court in Mumbai / Navi Mumbai.
- **12.20** Any dispute raised out of this appointment or in relation to this application shall be referred to Chief Commercial Manager, Konkan Railway Corporation Limited and his decision shall be final and binding on both the parties.
