
Sub: Provisional Panel-I for the post of Track Maintainer against notification no. CO/P-R/04/2025 dated 04/07/2025.

- 1) Konkan Railway Corporation Limited (KRCL) have issued vide Employment Notification No. CO/P-R/04/2025 dated 04/07/2025 for filling up posts in Erstwhile Group-D posts i.e. Points Man and Track Maintainer.
- 2) Based on Computer Based Test (CBT) result, document verification, on qualifying in Physical Efficiency Test (PET), post preference and number of community wise vacancies notified, provisional eligible candidates as per merit were called for Medical Examination for the post of Track Maintainer. Consequent upon passing the requisite Medical examination, provisional Panel-I of successful candidates for the post of Track Maintainer is notified as follows:

Track Maintainer: In this Panel, against notified 35 vacancies, total 30 (UR-22, SC-5, ST-3) candidates are provisionally empanelled. Panel will remain valid for two years. The provisional Panel-I for the post of Track Maintainer is attached as **Annexure-A**.
- 3) The Panel of successful candidates is only provisional. Roll numbers are arranged vertically in descending order and not as per merit.
- 4) While due care has been taken in preparing the Panel-I, in case of any inadvertent error/s is noticed at any stage, KRCL reserves the right to rectify the same at later stage of selection procedure.
- 5) KRCL reserves the right to declare any candidate unsuccessful or delete his/her name from the notified provisional Panel at any stage of the selection procedure, if any discrepancy or malpractice is noticed or brought to the notice of KRCL at any stage. The decision of KRCL in the matter shall be FINAL.
- 6) KRCL will not entertain any individual queries in this regard.
- 7) For any legal dispute, the jurisdiction will be Hon'ble High Court, Mumbai only.
