### I) Particulars of Organization, Functions and Duties

#### Overview

**KONKAN RAILWAY CORPORATION LTD (KRCL)** was incorporated on 19.07.1990 pursuant to an Agreement between Government of India acting through Ministry of Railways and the Governments of Maharashtra, Goa, Karnataka and Kerala and obtained Certificate of Commencement of Business on 20.08.1990 for construction and operation of the Konkan Railway, a Broad Gauge Railway Line along the west coast of India connecting Roha (in Maharashtra, near Mumbai) in the North to Thokur, (Near Mangaluru, Karnataka) in the South and for raising the necessary finance for the project from the market. The Project was envisaged under the BOT (Build-Operate-Transfer) concept for the first time in India. The line was commissioned on 26.01.1998.

#### Infrastructure Works

- **Doubling:** Konkan Railway has commissioned the double line between Roha & Veer for passenger traffic on 30.08.2021.
- **Electrification:** Electrification of complete KR Route has been completed and dedicated to the Nation by the Hon'ble Prime Minister on 20.06.2022.
- **Infrastructure Augmentation:** To increase the capacity of the Section, additional 10 additional crossing Stations and 08 new loop lines have been added in last three years.

#### The Corporation has also undertaken the following other activities in terms of the objectives:

- **Tunnels:** Owk tunnel in Andhra Pradesh, Jawahar Tunnel in Jammu & Kashmir and 11 tunnels of Mumbai-Pune Express Highway were successfully executed.
- **ROB:** Construction of 14 Road-over Bridges in Jharkhand State have been completed.
- **The Udhampur-Srinagar-Baramulla Rail Link Project** is a National Project. A 52.2 km stretch from Katra to Dharam was executed by Konkan Railway Corporation Limited. This section includes 44.59 km (86%) in tunnels, 4.6 km (8.6%) on bridges, and 3.01 km in cuttings and embankments, including the two iconic bridge across river Chenab (Arch Bridge) and at Anji Khad (Cable stayed bridge). The 272-km project is now fully operational, with train services running since its inauguration on 6 June 2025 by Prime Minister Narendra Modi.
- **MRPL Siding, Mangalore:** The MRPL Siding at Mangalore was executed by KRCL and facilitates the movement of commodities such as pet coke, sulphur, bitumen, and polypropylene.
- **Multimodal Logistic Park, Balli:** The Multimodal Logistic Park at Balli was executed by KRCL, and the siding facilitates the movement of containers.
- **NTPC Railway Siding Project:** NTPC awarded KRCL the work of preparation of the Detailed Project Report and construction of the coal transportation system for the Kudgi Super Thermal Power Project in Karnataka. Additionally, rail connectivity for the Super Thermal Power Plant at Gadawara, Madhya Pradesh, was also entrusted to KRCL under a Project Management Consultancy (PMC) contract.
- **Rolling Stock Component Factory at Lote, Ratnagiri:** The Rolling Stock Component Factory(RSCF) at Lote, Ratnagiri, a Central Railway project, was executed by KRCL. The facility was established as a nodal centre for the supply of critical safety components as unit exchange spares for freight wagons and Mail/Express coaches.
- **Thalassery to Mysuru New Railway line:** The Kerala Rail Development Corporation Limited (KRDC) had entrusted KRCL with the preparation of the Feasibility Study Report and Detailed Project Report for the proposed Thalassery-Mysuru new railway line, and the work was successfully completed.
- **Annampoyil-Kalladi-Meppadi Road Tunnel Project:** The Government of Kerala has assigned KRCL as the SPV for execution of the project, and a tripartite agreement has been signed between KRCL, the Public Works (H) Department, and the Kerala Infrastructure Investment Fund Board (KIIFB). The DPR has been approved, and land acquisition is in progress.
- **Rail Connectivity To Vizhinjam International Sea Port, Kerala:** Konkan Railway signed an MoU with Vizhinjam International Seaport Limited for providing rail connectivity between sea port to Balamapuram Railway Station (10.7 km) on a turnkey basis. The DPR has been approved, land acquisition is in progress, and the port was dedicated to the nation by the Hon'ble PM of India on 02.05.2025.
- **ECOR Works:** East coast Railway has awarded the work of Construction of Viaduct, Major Bridges, ROB's and other ailight works of Khurda Road – Bolangir new BG Rail Link Project to Konkan Railway. Work is in progress.

• **North Western Railway Work:** North Western Railway has awarded KRCL the work of execution of a new BG line in Ajmer Division (23.65 km), and the work is in progress.

#### Technologies

The following technologies were conceptualized and developed by the Corporation.

• **Automated Train Examination Systems (KR-ATES):** KR-ATES is a Way Side Equipment (WSE) being fully conceptualised and designed by a team of Konkan Railway to detect various defects in rolling stocks of moving trains which pass through it and provide an immediate alert to avoid unusual and accidents. Konkan Railway has been granted patent by Government of India for this technological innovation

• **New Automatic Coach Washing Plant of KRCL Design:** ACWP is a multistage external cleaning system for train coaches, within 15 minutes. ACWP also cleans the area of coach below the toilets which is otherwise not cleaned manually. Water used for washing coaches is treated and recycled & reused.

• **Boulder Netting & Geo Netting:** Konkan Railway engineers have introduced indigenously developed Boulder Netting and geo-netting to prevent boulder falls or soil slippage on railway tracks in cutting along its route, thus enhancing safety.

• **RO – RO (Roll – on Roll – off):** Scheme was started on 26th January 1999, which has enabled carrying loaded trucks directly on the railway wagons for reducing the expenditure on Diesel, wear and tear of tyres, and maintenance of trucks for the Truck Operators.

• **Electrification work:** Konkan Railway Corporation Limited has undertaken railway electrification works across various Zonal Railways, as well as other electrification works for State Governments.

• **Information Technology:** IT is one of the mainstays of Konkan Railway's functioning. IT has enabled Konkan Railway to become and remain efficient and lean. It supports all aspects of KR's operations through various ERP modules, integrated Railway Applications Package, a first-of-its-kind system in Indian Railways that remains unparalleled.

#### International Projects

- i. Konkan Railway has completed the order for supply of 2 DEMU rakes to Nepal Railway. Report submitted to MEA & RB on 24/03/2023. East Central Railway, vide LOA dated 13.03.2020 have awarded Final Location Survey for new BG Line between Raxaul and Kathmandu. Konkan Railway submitted the report to MEA & RB on 24/03/2023.
- ii. The Operation & Maintenance support Jaynagar-Kurtha section of Nepal Railway line is being done by KRCL. The inauguration of passenger services was done by the Hon'ble Prime Ministers of India and Nepal on 02.04.2022.
- iii. KRCL has signed a contract with M/s. Tata Chemicals Limited, Magadi, Kenya in December 2022 for Rehabilitation of Railway Systems.

#### Shareholding Pattern

Konkan Railway Corporation Limited is a Government Company incorporated under the Companies Act 1956 (now the Companies Act, 2013).

2. **Preference Share Capital:** The authorised Compulsory Convertible, Non-cumulative Preference Share (CCPS) Capital of the Corporation, as on 31.03.2026 stood at ₹4079.51 Cr., whereas the Paid Up CCPS capital stood at ₹3222.46 Cr. The entire CCPS is held by Ministry of Railways.

#### II) Powers and Duties of Officers and Employees.

Konkan Railway Corporation Limited is a railway transport organization wherein the powers of company officials are well defined at all levels of the organization. Duties have been assigned department-wise, and the brief functions of each department can be viewed on the Konkan Railway official website under the "Departments" tab.

#### III) Procedure followed in the decision-making process.

All activities of the organisation are governed by Schedule of Powers for Works, Stores, Financial, Establishment, General and Misc. Matters, wherein limits have been set for different levels of Executives. The proposal is routed to next higher level for decision making, in case the same does not fall within one's set Schedule of Powers. Hierarchy of Executives is the following rising order; Jr Scale, Sr Scale, Jr Administrative Grade, Selection Grade, Sr Administrative Grade, Higher Administrative Grade, Board Level Executives, Chairman and Managing Director. There are no specific timelines for taking decision. However, it is expected from the Executive concerned as per the SOP, to take decision at the earliest, depending upon the nature of the matter.

Konkan Railway Corporation Limited is governed by its Board of Directors comprising the Chairman & Managing Director (C&MD), three Functional Directors, two Part-time Directors from the Ministry of Railways, four Part-time Directors from the participating States, and four Independent Directors. The Board has constituted various committees such as the Audit Committee, CSR&D Committee, Risk Management Committee, Shareholders Committee, etc., in accordance with the provisions of the Companies Act, 2013. The meetings of these committees are not open to the public, and the minutes thereof are not accessible to the public. KRCL has entered into a uniform listing agreement with the National Stock Exchange of India (NSE) for listing of its Bonds, and Link Intime India Pvt. Ltd. is the Registrar and Transfer Agent for KRCL Bonds.

Konkan Railway's Average Redressal period during the last Financial Year was 15 days. **CPGRAMS** : Target for replying to the grievances is 21 days. Konkan Railway's Average Redressal period during the last Financial Year was 11 days.

Training programmes on the Right to Information Act, 2005 were conducted for Public Information Officers (PIOs) and other employees handling RTI matters at Madgaon on 25 November 2025 and at Corporate Office on 07 January 2026 and 16 February 2026. STQC Certification : The KRCL website received Standardisation Testing and Quality Certification Directorate (STQC) certification on 17.10.2025 (validity upto 16.10.2028), confirming compliance with Government of India standards for security and quality.
