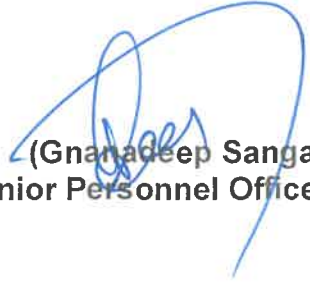
Notes:

With reference to Railway Board Letter No. 2018/E(O)II/41/1 dated 08.02.2023, applications of officers working in Zonal Railways/Production Units (PUs) for deputation to Railway PSUs, Autonomous Bodies, and other organizations shall be forwarded only with the approval of the Competent Authority in the Ministry. Accordingly, all Zonal Railways/PUs are required to forward such applications to the Railway Board well in advance, i.e., at least seven (07) days prior to the closing date mentioned in the vacancy notice. It is to be noted that KRCL will consider only those applications that are duly forwarded by the Railway Board.
