



The Food Safety and Standards Act 2006 (FSSA), Rules & Regulations 2011

The Food Safety and Standards Act 2006, Rules & Regulations 2011, a new act has come into force in place of earlier act “The Prevention and Food Adulteration Act 1954, Rules 1955” from 5th August 2011.

The Food safety and Standards Act, 2006 is defined as :

An Act to consolidate the laws relating to food and to establish the Food Safety and Standards authority of India for laying down science based standards for articles of food and to regulate their manufacture, storage, distribution, sale and import, to ensure availability of safe and wholesome food for human consumption and for matters connected therewith or incidental thereto.

According to this act, All Food Business Operators (FBO) in the country will be registered or licensed in accordance with the procedures laid down. The Petty Food Business Operators with an annual turnover not exceeding Rs.12 lakhs shall register themselves with the respective Registering Authority and the Food Business Operators with an annual turnover exceeding Rs.12 lakhs shall obtain license from the respective Licensing Authority.

As per provisions under FSSA (Licensing and Registration of Food Businesses) Regulation, 2011, the categories namely, Food vending services and Restaurants operating from Railway area are covered under Central Licensing Authority.
