### PROVISIONAL RESULT FOR THE POST OF NTPC (SM ,Goods Guard, Sr Clerk and Accounts Assistant).

#### NOTIFICATION NO.CO/P-R/03/2018 DATED 05/04/2018

- 1) Konkan Railway Corporation Limited (KRCL) vide its Notification No.CO/P-R/03/2018 dated 05/04/2018 have issued Employment Notification for 4 categories of posts i.e. Station Master, Goods Guard, Senior Clerk & Accounts Assistant. The Computer Based Test (CBT) for this combined examination have been conducted on 04/07/2018 & 05/07/2018. Out of these 4 categories of posts, Aptitude Test which is mandatory for recruitment as Station Master (SM) was conducted on 7/1/2019. Result is here by declared for calling successful candidates for Document Verification. The result of successful candidates is only provisional. Roll numbers are arranged vertically in descending order and **not as per merit**. List of successful and Stand by candidates are enclosed as **Annexure-I to IV-A**. This result is available on KRCL website [www.konkanrailway.com](http://www.konkanrailway.com) → **Recruitment** → **Current Notification** → **Result**.
- 2) Aptitude Test have the weightage of 30% and 70% weightage is given to CBT for the post of SM. Aptitude Test qualified candidates, based on this integrated merit (CBT + Aptitude Test) post preference, merit position, etc. are listed for Document Verification for the post of SM. For other categories i.e. Goods Guard, Accounts Assistant and Senior Clerk the score of CBT conducted on 4/5th July are considered. Based on the merit position of the CBT post preference, educational qualification, etc. eligible candidates will be called for Document Verification. For the post of Accounts Assistant, only Commerce Graduates are eligible whereas for Senior Clerk, candidates having qualification of HR are rendered preference.
- 3) Candidates equal to the number of vacancies are published as Regular list and almost same number of candidates are published as Stand by list. List of Candidates in Stand by list are over and above the required vacancy, in case of shortage of candidates from regular list owing to absenteeism, medical unfit, any other reason, candidates from Stand by list will be considered strictly as per merit and reservation rules etc.
- 4) DV will be tentatively scheduled in the month of March-2019. The exact date will be notified shortly. Candidates are advised to visit KRCL website [www.konkanrailway.com](http://www.konkanrailway.com) regularly for getting themselves updated.
- 5) Online call letters will be issued 10 days prior to the scheduled date of DV. Candidates have to produce the print out of the same on the venue of DV.
