- ii) Other than Konkan Railway land losers, **only SC/ST candidates from Employment Exchanges** along Konkan Railway route within the jurisdiction of Konkan Railway Corporation Ltd. (Raigad, Sindhudurg and Ratnagiri Districts of Maharashtra; Goa State; and Karwar, Udupi and South Kannada Districts of Karnataka)are eligible.
- iii) Employees/Trainees of Konkan Railway are not eligible.

### 2. Educational Qualification

Matriculation plus Course Completed Act Apprenticeship/ITI approved by NCVT/SCVT in the trade of Electrician/Wireman/Instrument Mechanic / Mechanic Armature & Coil Winder / Electronics Mechanic / Mechanic (Refrigeration & AC). Candidates appearing at and/or awaiting result are not eligible. Applications not accompanied with above certificates will be rejected.

#### 3. Age

The candidates should be within the age group of 18 years (minimum) and 32 years (maximum) as on 01/01/2013 with 5 years Upper Age relaxation for SC/ST candidates.

## 4. <u>Job Description</u>

They shall assist their supervisors in all day to day works associated with maintenance and up keep of electrical installations and assets as given below, in brief;

- 1) Electrical installations at Sub-stations, Railway Stations, Coach Maintenance Depots, Tunnel Ventilation, Control Rooms, Rest Houses, LC gates, Running Rooms, Office Buildings, Staff Quarters, Community halls, Lighted and Ventilated tunnels etc..
